Top-Werk companies SR-Schindler (concrete slabs and coating equipment) and Prinzing (concrete products for infrastructure). Hess has a workforce of around 750 employees at production sites in Germany, the Netherlands, France, Russia, China, India and Mexico, as well as sales and service centres in Canada and Dubai.

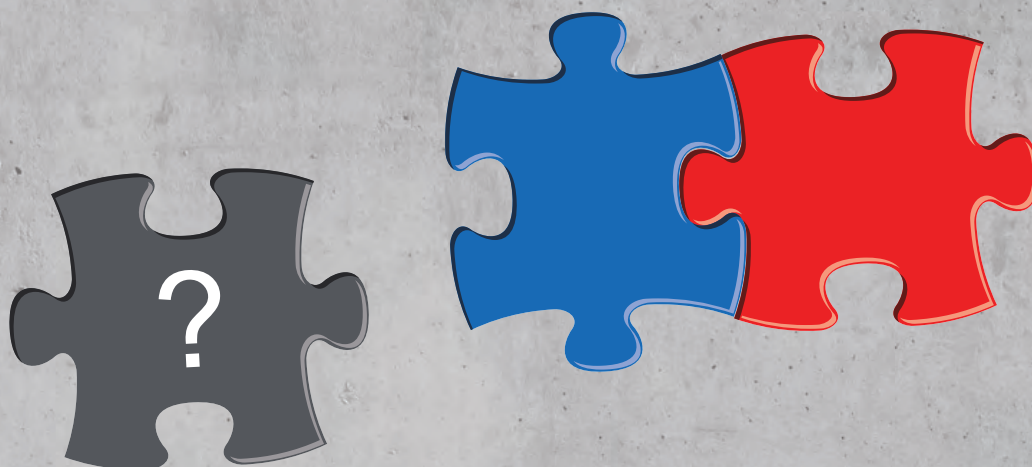
The merger is receiving corporate and financial advice from CGS, an international industrial investor with roots in Switzerland.

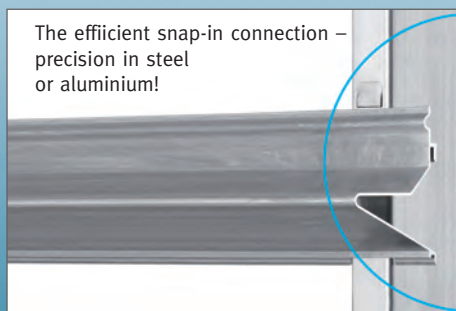
