A cornerstone investment for the future: Ceremonial factory inauguration in Ukraine

In April 2014 the most modern dosing- and mixing plant in the Ukraine was put into operation. Magik Ltd. was founded in April 1993 and developed rapidly into one of the leading manufacturers of high quality concrete blocks in the Ukraine.

First successful conversations – the begin of a fruitful relationship

In 2008 the first discussions took place between Serhiy Lichnov, CEO, Magik Ltd. and Frank Reschke, Masa GmbH. Very quickly they recognized that both parties were looking forward to a fruitful relationship. Magik Ltd. was aware that it is only possible to produce high leveled concrete blocks if one begins with excellent raw materials. This is why Magik Ltd. invested first in off-shore processes, which was necessary to treat the different raw materials. After establishing this criterion, the time was right for the next step.

Investment for the future – Quality from the outset

As early as 2013 the idea was to look forward to optimize process improvement. The conclusion was the need to invest in a new dosing- and mixing plant. Magik Ltd. purchased a high class dosing- and mixing plant in Oct. 2013 from Masa, located in Andernach, based on the very good relationship between the company from Lviv and the Rhinelander company.

On time delivery – Masa Mixer S350/500 and PH 1500/2250 put into operation

The putting into operation of the new Masa Mixer S350/500 and PH 1500/2250 needed a completion date by April 2014. Therefore, a tight time schedule was agreed to between the two companies and Masa began the manufacture of the mixers in Germany. Within a very short period the mixer was punctually delivered in Lviv. "It is looking good. We are on schedule," was the message to a delighted Lichnov in February 2014. The assembly work of the Masa employees went smoothly and all work was completed on schedule. The new dosing- and mixing plant was as planned ready for use and another milestone was reached.


